# **ENDLESS SUMMER PASSPORT**

#### **CONDITIONS OF ENTRY**

- 1. Information on how to enter, the requirements of entry, details of the prize pool and other terms of the "Endless Summer Passport Promotion (**Promotion**) form part of these terms and conditions of entry (**Conditions**). Entry into the Promotion means that the entrant warrants that he/she meets the entry requirements and accepts these Conditions.
- 2. The Promotion commences at 10.00am (AEST) on Monday, 2 December 2019 and entries close at 10.00pm (AEST) on Tuesday, 31 March 2020 (**Promotion Period**).
- 3. Entry is open to all Australian resident passengers/visitors that visit Mackay Airport and spend \$10.00 or more in one transaction at each of the four participating outlets, listed below, which are located at Mackay Airport and also the Ibis Mackay Hotel Turbarlence Tavern during the Promotion Period:

- 4. Entrants must be over the age of eighteen (18) years at the time of entry into this promotion.

#### **HOW TO ENTER**

- 5. To enter the Promotion, entrants must complete the following entry requirements:
  - (a) Spend \$10.00 or more in one transaction at each of the four participating outlets during the promotion period;
  - (b) Get a stamp on the Endless Summer Passport ("passport") from each outlet to complete the passport with all four outlets stamped;

  - (d) Staple the four original receipts to the passport;
  - (e) Fill out the entrant's name, address, phone number and email address where indicated; and
  - (f) Place the passport in one of the promotion entry barrels or boxes at Mackay Airport or Ibis Mackay Hotel before the end of the promotion period.
- 6. To validate their entry, entrants must meet the following entry requirements:
  - (a) The four <u>original</u> receipts must be attached to the passport. A photocopy or other copy or reproduction of any receipt will make the entry invalid

- (b) Return airport transfers for four people, Queenstown Airport to accommodation
- (c) 7 nights' accommodation at Peppers Beacon in a Two Bedroom Garden Suite for 4 people
- (d) Skyline Gondola Queenstown -1 ride for four people
- (e) Shotover Jetboat Ride 1 ride for four people

  - (a) any technical difficulties (including viruses) or equipment malfunction (whether or

not under the Promoter's control);

- (b) any theft, unauthorised access or third party interference;
- (c) any redemption claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter;
- (d) any variation in Prize value to that stated in these Terms and Conditions;
- (e) any tax liability incurred by a winner or entrant; or
- (f) the use of the Prize.
- 16. Each entrant, including the prize winners and any travel companion:
  - (a) releases the Promoter to the extent permitted by law; and
  - (b) indemnifies the Promoter and will keep the Promoter indemnified,

### **HOW WINNERS ARE DETERMINED**

### **NOTIFICATION OF WINNERS**

- 18. The provisional winners will be notified by telephone or email within three (3) business days of the Prize draw. Failure to produce photographic identification, either a valid driver's license or passport containing the same details as those on the entry, when requested may, in the absolute discretion of the Promoter, result in forfeiture of any right to a Prize Package.
- 19. The Promoter reserves the right to verify the validity of entries and entrants and invalidate/disqualify any entry that is made that is not in accordance with these Conditions in its absolute discretion.

#### **UNCLAIMED PRIZE DRAW**
